OVERVIEW

Through a series of meetings, City of Tucson Mayor and Council authorized the allocation of \$1,850,000 of Federal CARES Funds in support of arts and culture. The Arts Foundation for Tucson and Southern Arizona was enlisted as the community partner to administer the Arts and Culture COVID-19 Assistance Grant and Entertainment Venue Continuity Grant. To this end, the Arts Foundation designed and launched three new emergency relief grant programs with multiple deadlines. These programs provided critical financial assistance to support the workforce, nonprofits and businesses that operate in the Arts and Culture Economic Sector.

This unprecedented investment by the City of Tucson underscores the benefits that the arts sector brings to its residents and its tremendous capital contribution to the local economy.

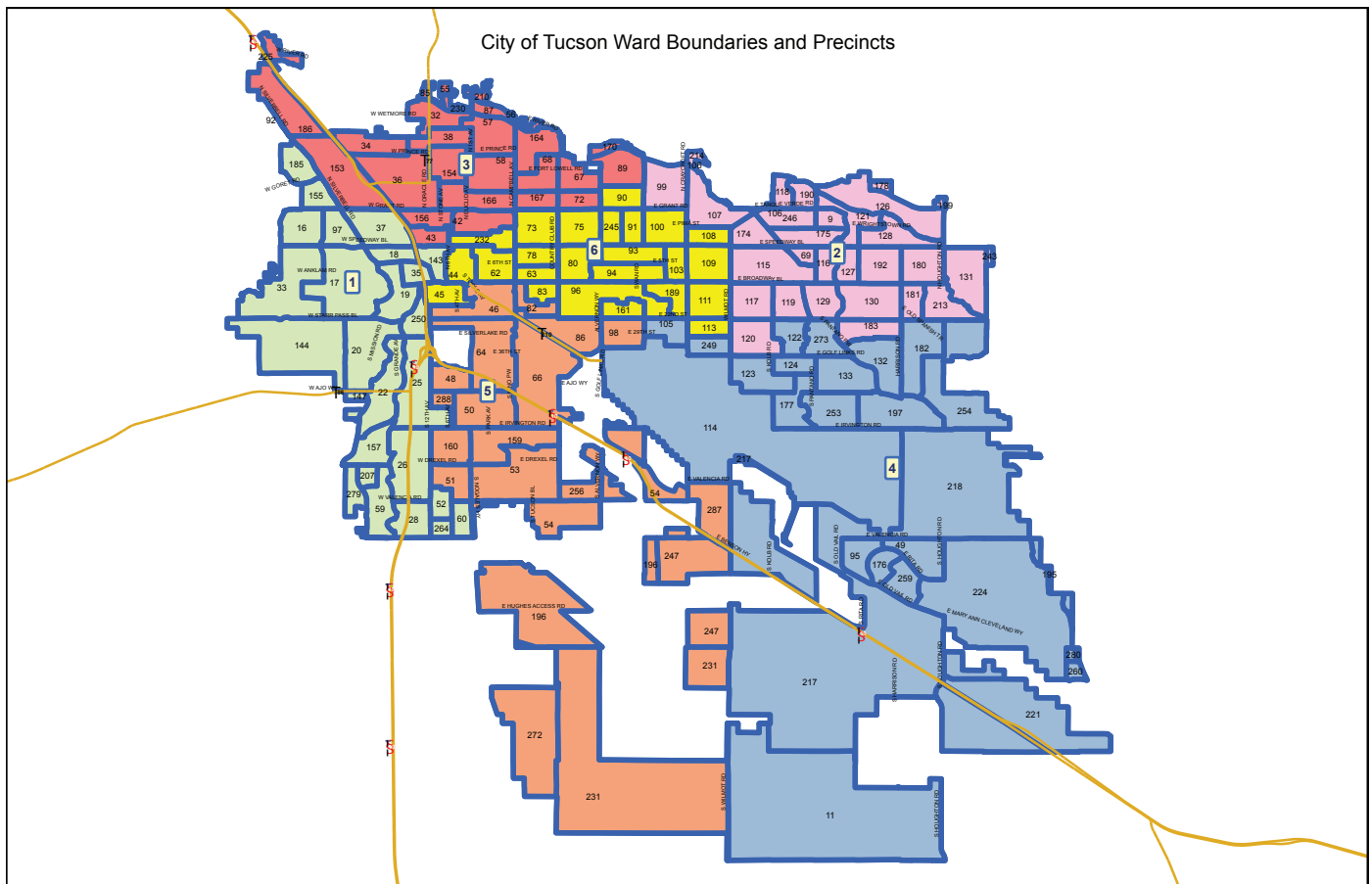

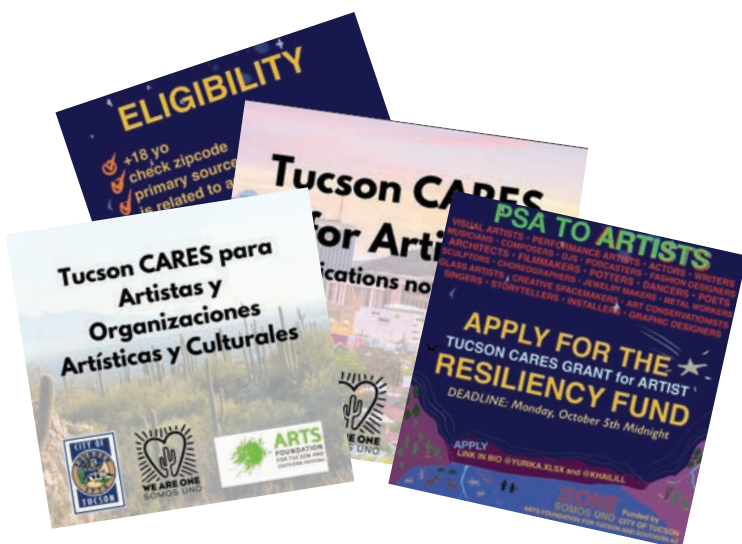
Grant program information was disseminated through our strong partnerships with local news outlets, Mayor's Office, and Ward Offices. Social media platforms were activated to create relevant and timely content to reach distinct audiences. Single posts were shared more than 342 times and translated to 144 website clicks.

One-on-One Multilingual Application Assistance

Arts Foundation Staff, Board of Directors and Consultants hosted a series of 30-minute, one-on-one multilingual consultations to assist individuals, nonprofits and businesses throughout the application process.

Multiple Modes of Communication Offered: Phone Calls, Texts, Chat Channels, Video Conferencing

Additional support services via alternative communication methods, were made available to applicants in response to variances in their technology needs.



66% First time Applicants

Arts and Culture COVID-19 Asst. & Entertainment Venues Continuity Grants

Arts Foundation Board Members were among the first community leaders to volunteer their time to review applications for eligibility. This process bridged a direct understanding of the financial distress affecting the artistic communities we are beholden to. As additional relief and grant programs were made available, the Arts Foundation contracted with a variety of community peers, creative professionals, consultants, and volunteer board members to help review eligibility for hundreds of applications via multiple deadlines. Two professional grant consultants were contracted respectively, to manage the Arts and Culture COVID-19 Assistance Grant Program and the Entertainment Venues Continuity Grant Program.

All internal and external personnel with access to applications underwent Anti-Bias Training, Conflict of Interest Disclosure, and Information Disclosure. Sensitive information, such as demographics and personally identifiable data within each application remained undisclosed to reviewers.

Extensive Checks To Confirm Eligibility 167 Follow Ups Conducted with Applicants

Over 167 applications from artists, nonprofits and businesses required further verification of eligibility during the review process. The courtesy outreach and individualized assistance resulted in fewer applicants being turned away.

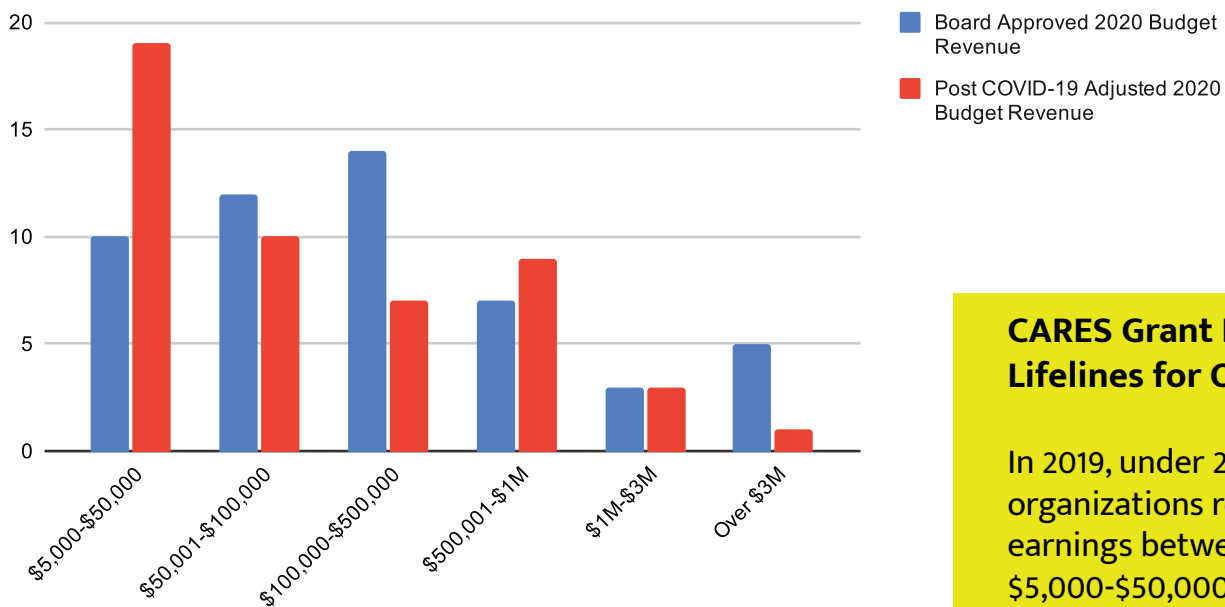

Financial Impact

Revenue Decline Across Nonprofits of all Sizes and Disciplines

Arts Foundation collected data from 51 nonprofits and grassroots organizations operating in the Arts and Culture sector to analyze the financial consequences of the pandemic. A total of \$23,138,043 was reported as lost income from the 51 Arts and Culture Organizations. 33% of organizations reported a total loss between \$20,000-\$50,000. While some organizations operate at limited capacity following city guidelines, many have cancelled in-person services, performances, and exhibitions.

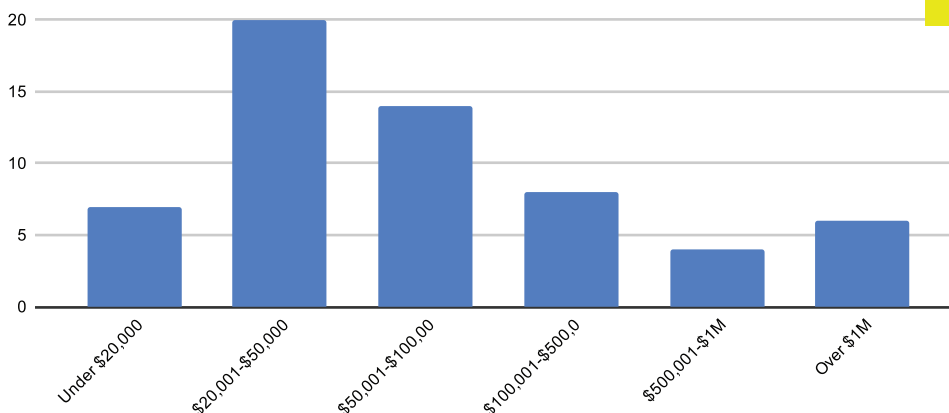
Change in Estimated Budgeted Revenue for Organizations



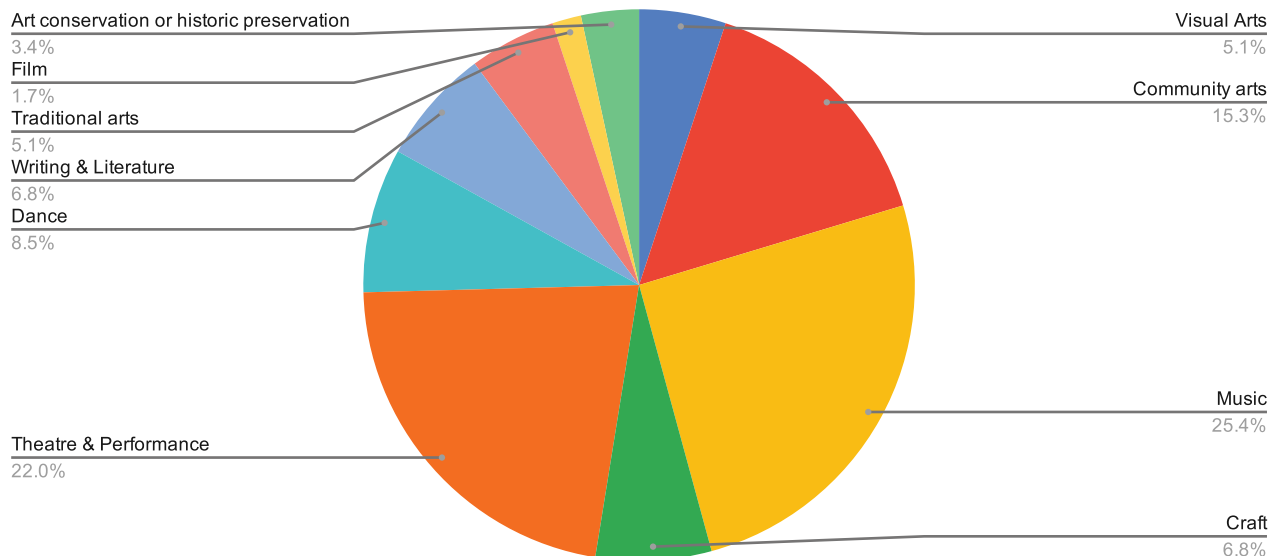
CARES Grant Provide Lifelines for Organizations

In 2019, under 20% of the organizations reported earnings between \$5,000-\$50,000. In 2020, over 37% of the organizations land in the lowest revenue bracket.

Funds Reach Disproportionately Affected Communities

As the pandemic amplifies the social, economic and health risk factors that these communities already face, art organizations stepped up to provide new programming to address critical issues of compounded by financial distress and mental health. Arts organizations remain committed to upholding mission-driven work to serve Tucsonans throughout the devastation of the pandemic. Of all 59 organizational grantees, 35% reported having a mission and programming that was explicitly dedicated to a specific cultural community.

Critical Programs Supported

"Funding from the Tucson CARES grant would go towards salaries, unemployment benefits, and health benefits of the 72 musicians of the Tucson Symphony Orchestra. Between April-June the TSO incurred an unexpected \$14,000 in unemployment expenses, and expects to incur much more in FY2021 because contracted musicians will be paid out on a per-service basis rather than a salaried basis. Health care and salaries total approximately \$390,000 for the year."

"A grant from the Tucson CARES for Arts and Culture Fund would mean continued employment for LTW staff and artists, continued programming for students and schools, and greater stability for the organization when COVID conditions improve. LTW will use these funds to support salaries, teaching artist stipends, and technology adaptations for youth programming. While all LTW youth programs are being offered in the digital space, need and interest is higher than ever, on the part of youth, parents and schools. LTW youth programming is filling a void of physical and creative mental activity, social connection, and fun that youth need right now."

"Funds from Tucson CARES will be used to directly support our most impactful education program, Satellite, which serves over 4000 youth in Title 1 schools across Pima County each year. Satellite would have been supported by \$150,000 revenue lost due to COVID-19 between March 1-December 30, 2020....This program has shown an overwhelming need for arts programs that supplement K-12 curriculum, specifically during this time of isolation and social-distancing. MOCA Tucson is currently booked with virtual classroom visits through October and into November, having already served over 1200 youth in Title 1 schools in the first two months of the 2020 fall school year."

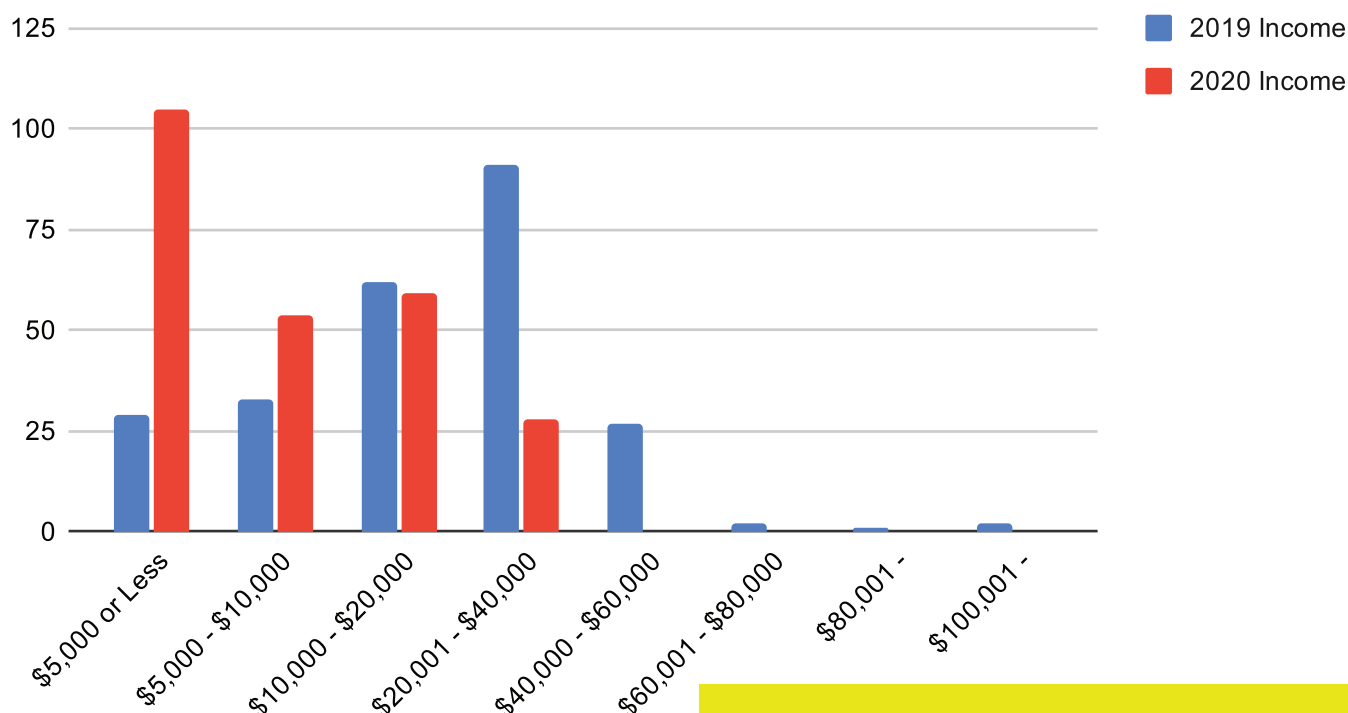

The Creative Workforce

Nationwide, an estimate loss of 2.7 million jobs and more than \$150 billion in sales of goods and services were lost in the Creative Sector due to the pandemic*. These numbers are directly reflected in the average earning of applicants to the Tucson CARES for Artists Program. In a sample of 274 Tucson creative professionals, we see a significant dip in average annual income. In 2019, over 40% of the artists reported earnings between \$20,000 to \$40,000. In 2020, over 40% of the artists reported an annual income of less than \$5,000.

Application Question: In 2019, approximately what was your total individual income from all sources (including both art and non-art-related income), before taxes?

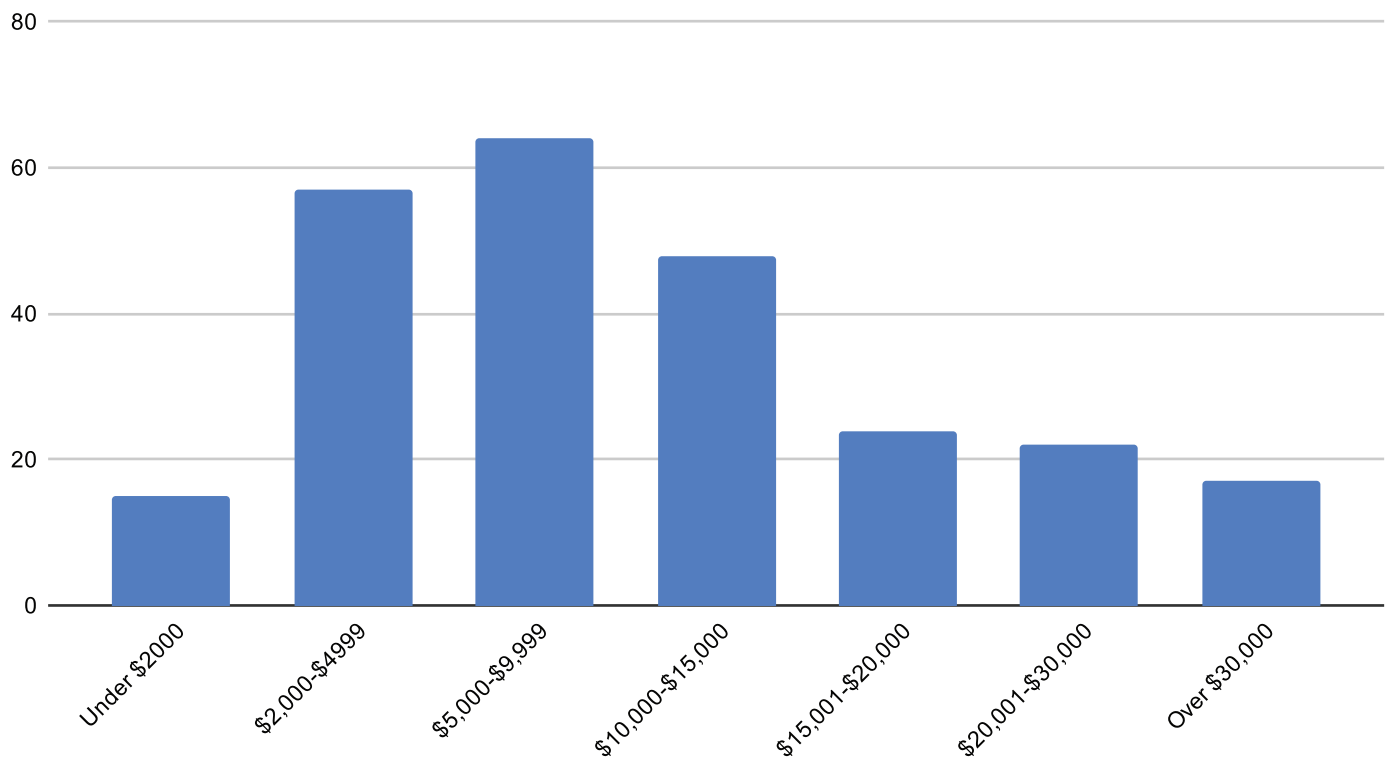
Since the 2020 COVID-19 pandemic, what is your best guess for your total 2020 individual income from all sources (including both art and non-art-related income), before taxes?

In an exit survey conducted with 21 Artist Grantees, 68% of grantees did not receive Pandemic Unemployment Assistance (PUA) nor AZ Unemployment Insurance in 2020. 18% did not receive the first stimulus check issued in the summer of 2020.

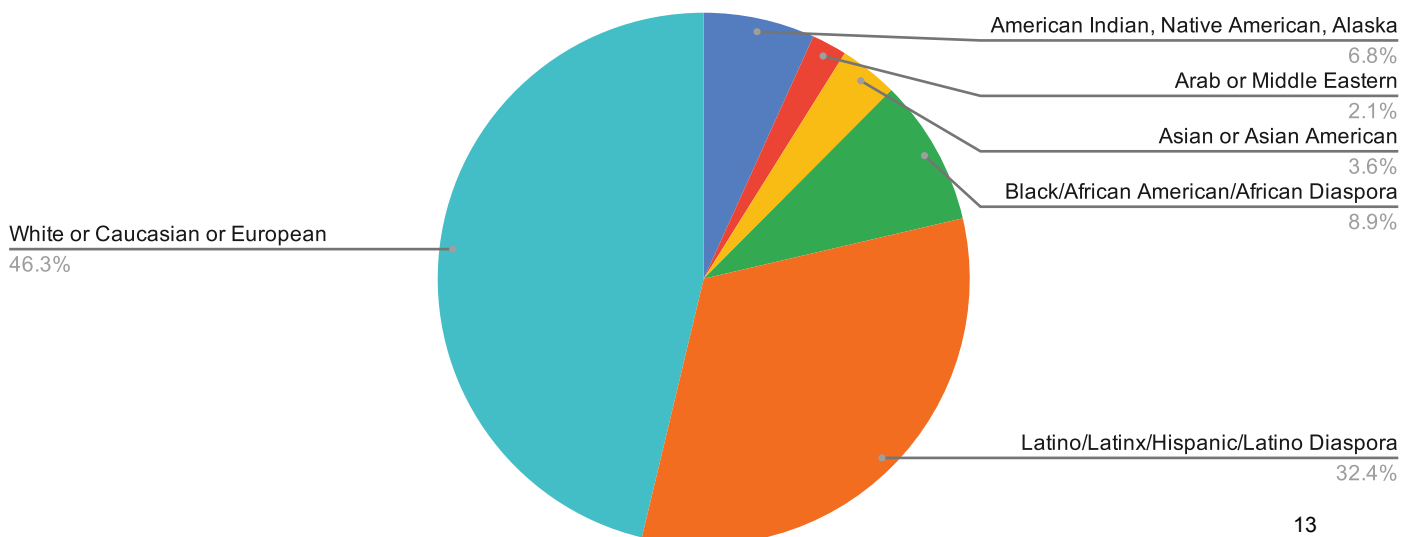
CARES for Artists Workforce Relief Program Demographics

Tucson CARES for Artists Grantees are representative of Tucson Demographics

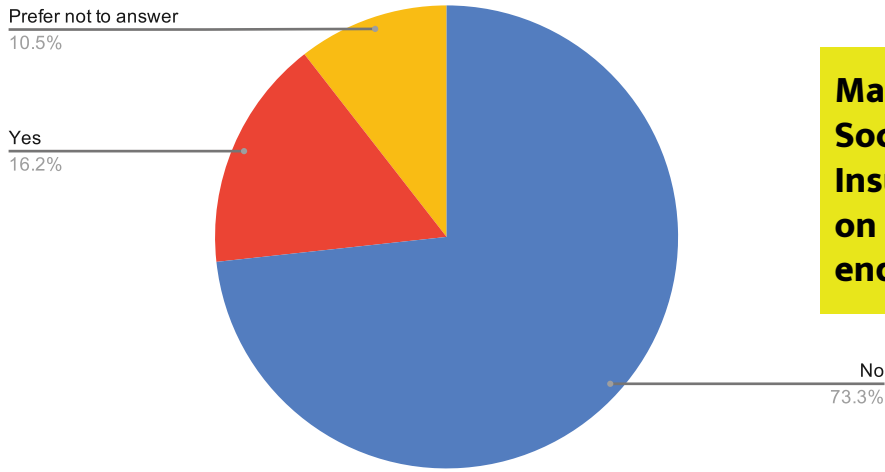

2020 CARES for Artist Grantees: Racial and Ethnic Identification

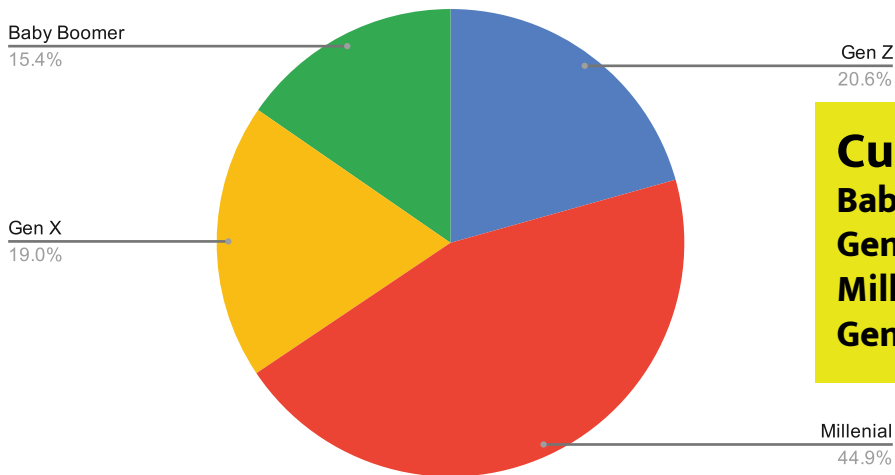


2020 CARES for Artist Grantees: Disability Identification

The most common reason for rendering an application completely ineligible was due to business or residential addresses that were located outside of Tucson City Boundaries. The Arts Foundation will continue to work closely with Local, State, Regional and National public and private funders to identify additional relief efforts to help our neighbors who may not otherwise have access to these types of funds.

As described in the Review Process section of this report, 167 applicants who otherwise would have been ineligible due to technicalities or insufficient documentation, received follow-up assistance to double check their eligibility status. These customized consultations helped applicants organize their finances, clarify any gaps of information, and assured constituents that they were not alone throughout this process. With this high degree of individualized service, the Arts Foundation was able to award over 88% of applicants. 100% of applicants received phased notifications on their application status.
