

OPEN STUDIO TOURS

Open Studio Tours (OST) is an annual event where artists open their studio doors to the public both in-person and virtually. This three-day event, organized by the Arts Foundation, showcases our community's vibrant creativity and fosters deeper connections between artists, art enthusiasts and the general public who visit their studios. In-person visits are available throughout the greater Tucson area, while virtual tours are accessible to those within the Arts Foundation's service region.

Artists participating in OST invite members of the general public and art enthusiasts to explore their studio spaces to share insights into their artistic process and inspiration. This intimate engagement provides artists with the opportunity to showcase and sell their artwork without incurring application fees or commissions. OST promotes local talent and supports the growth of our creative economy by eliminating barriers of engagement between artists and potential buyers.

The Arts Foundation welcomes creatives from any art discipline, including but not limited to visual artists, ceramists, jewelers, designers, musicians, writers, poets, spoken word artists, dancers, actors, and filmmakers, to showcase their workspaces, processes, and creative work.



STUDIO SPOTLIGHT: VIDEO SCHOLARSHIP

Open to Artists located in the greater Tucson Area.

The Studio Spotlight Video Scholarship is an exciting opportunity for Tucson artists to receive professional videography service.

The scholarship is lottery-based, meaning that any artist who applies has an equal chance of being selected. The scholarship is designed to produce high-quality videos that showcase the artistic process in the workspaces of the selected artists. This can be particularly beneficial for artists who do not have conventional studios or workspaces, as it provides an opportunity to showcase their work in a professional and engaging way.

To apply: You can enter the lottery through the OST Registration form on Submittable. Refer to Registration Questions – Section 8. Awarded artists will be announced in September 2024.

HOW TO REGISTER

- 1. Visit the Arts Foundation's 2024 Open Studio Tours web page to access guidelines and registration link.
- 2. Review the complete guidelines, registration questions, and FAQs (Appendix A)
- 3. Prepare responses, including Contact Information, Artist Headshot, Artist Bio, Artist Process Narrative, Creative Work Samples, Studio Photos, and Studio Tour Date and Time Availability. See Submission Material Guidelines for details.
- 4. Go to the online registration form, Submittable: LINK
- 5. Refer to the correct listing for 2024 Open Studio Tours Registration.
- 6. Create a Submittable account. If there is a pre-existing account, login.
- 7. Complete the online registration form.
- 8. Review all responses for accuracy. Click "Submit Form" to complete the registration process.
- 9. Submit the complete registration before the deadline. No late registration forms will be accepted after the published deadline for this program.

TECHNICAL REVIEW

- 10. Once the registration form is successfully submitted, a confirmation email will be sent to the email address associated with the Submittable account.
- 11. All registration forms will be reviewed for eligibility.
- 12. Artists will be notified of their status (approved or ineligible) via email.
- 13. Approved registrations will be published on the artist's Event Page on the OST website. *Only permissible sections of the registration form will be made public, as noted in the registration process below.*

- **Studio Interior Photos** Upload at least one high-quality photo of the interior of your studio (3 images max). Each photo must not exceed 2 MB.
- **Studio Exterior Photo** Upload one high-quality photo of the exterior to help visitors locate your studio more easily. Photo must not exceed 2 MB.
- **Description of your event** Briefly describe the type of experience visitors can expect. Will there be live demonstrations, interactive displays, exhibited artwork, performances, video showcases, live music, etc? This should set expectations and entice visitors to attend your studio.
- Purchase Details Provide instructions on how visitors can purchase your artwork or tickets for upcoming events.
- **Studio Tour Date and Time** Indicate your availability during the tour to ensure visitors know when they can participate in your in-person or virtual tour.

APPENDIX A

FREQUENTLY ASKED QUESTIONS

Eligibility

Q. I don't have a studio. Can I still participate?

A. Yes, you can still participate. A studio can be any space where you create, such as a garage, backyard, living room, etc. We also recommend finding a gallery or collective space where you can showcase your work.

Q. Who can apply to participate?

A. Any artist aged 18 or older with a studio in the greater Tucson area can apply to participate. Additionally, artists within the Arts Foundation's service region can participate virtually. Galleries and collectives are also welcomed.

Q. Is there a registration fee?

A. No, there is no registration fee to participate in the Open Studio Tours.

Submitting the Registration

Q. How long will this program accept registrations?

A. All online registrations will remain open and available for submission until 11:59 P.M. Arizona time, on the deadline date published in the guidelines. We recommend you complete your online registration materials well before the deadline. The sooner you complete your registration the sooner your Open Studio Tours Profile will be live on our website.

Q. If I start an online registration through the Arts Foundation's Submittable, can I save it and submit later?

A. Yes, Submittable has a "Save Draft" function to save and complete the registration at a later time. It is advised that you save your application throughout the registration process to ensure that data is not lost by refreshing the page.

Q. Will I receive confirmation that my registration was received?

A. Yes, you will receive a registration confirmation to the email associated with your Submittable account if we successfully received your registration.

Q. Will my application be published?

A. Not all sections of your registration will be published. Please refer to each question in the registration for specific details on what will be made public.

Event Promotion and Attendance

Q. How will the event be promoted?

A. The Open Studio Tours will be promoted through various channels, including social media, local media, newspapers and our website. Artists may also be asked to participate in promotional activities.

Q. Does it cost anything to attend Open Studio Tours?

A. Open Studio Tours is free to attend! We encourage attendees to consider purchasing artwork to support local artists.

Preparation and Participation

Q. What should I prepare for the Open Studio Tours?

A. Ensure your studio is clean and organized, have a selection of artworks ready for display, and be prepared to discuss your artistic process and works with visitors.

Q. Can I collaborate with other artists for a shared studio space?

A. Yes, collaborations are encouraged. If you share a studio space with other artists, please mention this in your registration, specifically in your Event Description (Section Three – Question 2). We recommend that each artist apply individually to create their own profile and gain more visibility.

Q. Are there any promotional materials provided to artists?

A. Yes, the Arts Foundation will provide promotional materials, including posters, flyers, and digital assets to help you promote your participation in the event.
